- Candidate must take their seats at least 5 minutes before the time appointed for the commencement of the examination.
- No candidate will be allowed to leave the Examination Hall until an hour has elapsed from the time when the papers are given out. Except as hereinafter provided, no candidate will be allowed to re-visit the Examination Hall during the hours of examination, after once leaving it, not to leave the Hall without giving up his answer paper. A candidate may, with the special permission of the Officer-in-Charge, leave the examination Hall temporarily for a necessary purpose, but on re-entry the surveillance of a trust worthy person to be appointed by the Officer-in-Charge under proper safeguards to render accurate to verify previous responses. A candidate having completed his answer paper must hand it over every 15 minutes, to an invigilator before leaving the Examination Hall. The answer paper must not be allowed to be left on the desk. No candidate will be allowed to remain in the Examination Hall after the close of the examination, except to allow his answer paper to be collected by the invigilator.

- Candidates are forbidden to carry into the Examination Hall or have in their possession while under examination, any book, note paper, writing, scribbling or other materials except their Admit Card, University Registration Receipt and any other writing regarding or showing preferences. Any article carried into the Examination Hall or found in the possession of a candidate in contravention of this rule shall be liable to be seized by the Officer-in-Charge and the candidate shall be liable to expulsion.
- A candidate while under examination shall not help or try to help any other candidate, nor advise or try to obtain any help from any other candidate or other person.
