**REMARKS :-**

1. The validity period of TET qualifying candidate for appointment, unless otherwise notified by the appropriate Government, would remain valid for life.
2. This Mark Sheet cum Certificate shall be valid only on obtaining valid D.El.Ed/B.Ed Certificate as notified in NCTE Notification.
3. Qualifying TET would not confer a right on any person for recruitment/engagement as teacher as it is only one of the eligibility criteria for appointment as teacher, the other criteria being academic and professional qualifications as per NCTE norms
4. The documents of TET qualified candidate will be verified during the time of teacher engagement process by the concerned authority. In case of submission of false information/claim regarding qualification etc., he/she will not be eligible for appointment/recruitment as teacher and his/her TET Certificate will not be considered as valid.
