Memorandum of Understanding (MoU)

between

Purpose:

This Memorandum of Understanding (MoU) establishes a partnership between Barbhag College and 48(2) No. Kalag Gaon Panchayat for the safe and effective disposal of waste generated by Barbhag College.

Scope:

The waste to be disposed of includes, but is not limited to, paper, plastics, glass, organic waste, and hazardous waste. 48(2) No. Kalag Gaon Panchayat agrees to dispose of the waste in accordance with all applicable regulations and laws governing such disposal.

Responsibilities of Barbhag College:

1. Ensure that all waste generated by the institution is properly separated and stored in designated containers.

Responsibilities of Barbhag College:

1. Ensure that all waste generated by the institution is properly separated and stored in designated containers.
2. Respect and follow all standard guidelines and recommendations for safe disposal of different kinds of wastes.
3. Provide access to the waste disposal site to the concerned personnel of 48(2) No. Kalag Gaon Panchayat, when needed.
4. Pay all fees associated with the disposal of waste.

Responsibilities of 48(2) No. Kalag Gaon Panchayat:

1. Provide Barbhag College with waste disposal guidelines and recommendations.
2. Collect and dispose of waste generated by the institution.
3. Dispose of waste in accordance with all applicable laws and regulations.
4. Deliver receipts indicating the amount and type of waste collected and disposed of.
5. Provide regular updates and reports to Barbhag College on the volume and type of waste collected and disposed of.

Term:

This MoU is valid for a period of 5 (five) years from the date of signing by both parties.

Termination:

Either party may terminate this MoU at any time, with or without cause, upon providing thirty (30) days' written notice to the other party.


Amendments:
